STUD CONTRACT

GENERAL TERMS OF THE AGREEMENT:

Stud Dog Owner and Bitch/Litter Owner enter into this agreement for Stud Service with the intent to produce a healthy litter of puppies and good representatives of the Cavalier King Charles Spaniel Breed. The Bitch owner agrees that absolutely no puppies will be sold to pet stores, puppy mills, puppy brokers, backyard breeders, or anyone else who intends to breed the dogs without regard for registration and health testing. The Bitch Owner agrees to register all puppies with the AKC at the minimum.

PUPPIES:

Bitch owner agrees that puppies resulting from this litter will be sold on limited registration only with a spay/neuter registration/contract, except those kept by the bitch owner/co-owner, unless the owner of the stud dog otherwise agrees in writing.

In the case of Breeding with a FRESH CHILLED shipped collection: Progesterone testing is required. All collections will be done by the Stud Dog Owner's vet. Bitch Owner is responsible for the cost of shipping the collection and any costs pertaining to it.

In the case of Breeding with a LIVE COVERAGE (side by side at stud owners Vet) Progesterone testing is requested - For the protection of the stud dog and all other dogs on the premises, the bitch owner certifies that their bitch is free from disease and parasites and neither the bitch nor any kennel mates have been ill in the last 60 days. Bitch owner will provide

heart certification that bitch has no current heart murmur and a negative Brucellosis test, no older than 14 days (not needed for shipped collections or a side by side AI) Stud Dog Owner will provide to Bitch Owner the following: - A copy of the current health clearances - and approval of litter registration once the litter is born and registration has been applied for.

DEFINITION OF LIVE LITTER:

For use in this agreement, the definition of a litter of puppies is considered to be two live puppies at the age of 2 weeks. If bitch does not whelp a litter of two or more live puppies to the age of 2 weeks, the stud dog owner will provide one repeat breeding. No cash refunds on stud service shall be given. Costs involved in the repeat breeding will be the burden of the bitch owner.

Stud Dog Owner:

Stud owner certifies that the stud dog is healthy at time of breeding and has passed his yearly health certificates. As of 06-27-2019 he is certified for Heart, Eyes, Patellas and DNA clear for EF, CCDE, and DM. He is also a proven stud.

All legal fees and court costs incurred shall be the obligation of the Bitch Owner/s including all those incurred by the stud owner should litigation occur. Should any part of this agreement be found to be illegal or invalid or unenforceable in a court of law, the remainder of this contract shall remain valid and enforceable.
